
Food Council MRA

- Platform of citizens' initiatives aiming at transformation of the current food system, aspiring to promote food democracy and the forging of short food supply chains.
- Means: establishing contacts and exchanges and pooling resources with government, business corporations, producers, consumer groups, banks, press, research and educational organisations.

Amsterdam Metropolitan Area

- 2,5 million inhabitants
- 2,580 square kilometers/996.143 square miles
- 32 municipalities
- Prosperous region, Amsterdam economic and demographic magnet – population growth expected from 880.000 to 1.040.000 between 2020 and 2040
- Amsterdam harbour European hub for cacao
- Ymuiden:large fish harbour and fish auction
- Major producer of agricultural products: bulk exported
- Home of large food processing companies: Ahold, Verkade, Wessanen



Why urban and metropolitan food policy?

- Food is the subject of 20% of all consumer choices in retail
- 25% of all jobs in the services sector are related to food
- 10% of all jobs in the industry are related to food
- All ingredients on plate have travelled 33.000 miles
- Airport Schiphol is major hub for import and exports of fresh vegetables and fruits
- Few young people want to work in agriculture
- 30% of all motorized traffic by road is related to food
- 40% of all waste is related to food
- 30 % of food is wasted
- 15% of young people are obese
- 95 % of all food produced in MRA is exported
- Amsterdam harbour is mainport for imports and exports of fodder, cacao, fish
- 1200 people in Amsterdam depend upon food banks

Food democracy

Emphasizes fulfillment of the human right to safe, nutritious food that's been justly produced.

It means ordinary people getting together to establish rules that encourage safeguarding the soil, water and ecosystems that, in the end, we all depend on.




- Summer 2021 foundation of a Food Council for the City of Amsterdam by the city (i.e. the third food council)
- Nodes in regional network – personal connections. Arnold van der Valk is member of all three councils.
- How to change from persons to practices?

Conclusions

- Urban and regional food policy can solve food related issues and opportunities
- Food democracy is becoming an issue in multi-cultural Amsterdam
- Urban and metropolitan food policy since 2007
- Food governance: from triple helix to quadruple helix
- Establishment of three food councils reflects the traditional distinction between the conventional industrial global food system and an alternative regional and local niche food networks
- Today in the MRA distrust, competition and exclusion (by regime forces) gradually turning into mutual trust, inclusion and cooperation.



BEING IN A FOOD COUNCIL AS A CITIZEN COLLECTIVE

- Citizens can have a crucial impact.
- A food council needs to adapt to make citizen participation meaningful
- A citizen collective will need to search how to create trust in democracy and policy
- Some concrete questions and advice to open discussion





- 2010: transition group climate neutral Ghent
- Volunteer-based, open to everyone
- Core team (6-10-3)
- Urban Agriculture in its richest dimension

- Started in 2013
- 32 members
- 5 strategic goals
- Embedded in cabinet (city-led)
- Quite autonomous council



1. Provide information (website, facebook)
2. Organize dialogue and knowledge exchange (monthly fora)
3. Represent UA in all its dimensions



How to make citizen participation work?

FOODSHIFT
2030

Council

- Communicate about your policy council
- Make your council's decisions matter
- Provide solution for inclusion of non-paid members
- Make food policy councils meeting open to public
- Gather interest around your goals (survey, interviews,..)

Citizen Collective

- Invite policy makers (fora, meetings)
- Believe in collective dimension of democracy and food systems
- Try to be a throughput between public and empowered space
